RECRUITMENT OF SCIENTIST 'C'

[ON DIRECT RECRUITMENT (DR) BASIS] : 1 Post (UR)

Saha Institute of Nuclear Physics (SINP), Kolkata, a grant-in-aid Institution under the Department of Atomic Energy (DAE), Government of India, is one of the premier Institutes of basic scientific research. SINP is looking for filling up of 01 (one) post on **DIRECT RECRUITMENT** basis as indicated below:

The selected candidate will be entitled to draw D.A, H.R.A, and other allowances as per the rules of this Institute.

Post : Scientist 'C' : 1 Post.

(a) Essential qualifications & Experience :

- First class (60% marks) in M.Sc in Physics/Chemistry from a recognised University/Institution.
- Certified operator with minimum of 2 (two) years post qualification experience in the field of radiation surveillance supported by personnel monitoring service in a radiation processing facility.

OR

- First class (60% marks) in M.Sc in Radiological Physics.
- Minimum 2 (two) years post qualification experience in the relevant field as RSO.

(b) Desirable Qualification:

- Certification of successful completion of training in Radiological Safety Engineering or Advanced Diploma in Radiation Protection (Health Physics) conducted by BARC, AERB or equivalent AERB-certified institution.
- M.Sc in Radiological Physics leading to RSO (Industry & Research) certification from a recognised University/Institution.

(c) Age limit : 30 years on the closing date for submission of online application. Relaxation of age limit, if any, will be as per GOI rules.

(d) Selection Procedures: The shortlisted candidates among eligible applicants meeting the requirements as per the advertisement, usefulness of his/her expertise in the relevant field and essential qualifications will be called for Interview. A written test may also be conducted. Final selection will be made through in-person interview.

(e) **Job Description:**

The selected person needs to carry out radiation safety surveillance and related work. He/ She should work towards ensuring that regulatory norms on radiation safety as stipulated by the Competent Authority of Atomic Energy Regulatory Board (AERB), GOI are followed for the practices Sealed sources, Research (open sources), Research Accelerator Facility, Consumer products (X-ray facility) and any other practices that may come up in future.

HOW TO APPLY :

All applicants have to login to the application portal at www.saha.ac.in and fill up the application form online. The following **Self Attested** documents have to be kept ready.

1. Document in support of age (school passing certificate/admit card/passport).
2. Document in support of Educational qualifications & Experience certificate.
3. PwBD Certificate, if applicable.
4. Any other information the applicant may wish to share.

After submitting the online application, applicants are requested to send a printout of the submitted Online Application Form (in duplicate) duly ink signed with blue ink to be received within prescribed due date with the requisite fee through online remittance along with duly self-attested documents in support of age, educational qualification, experience and No Objection Certificate etc. Hard copy enclosing the requisite documents may be sent (by post) to The Registrar, Saha Institute of Nuclear Physics, 1/AF, Bidhannagar, Kolkata-700 064. While sending the hard copy of the application form please write the online application number, name of the applicant and post applied for on the Envelope. Application received after last date shall be treated as "REJECTED". Application without requisite documents will also be treated as "REJECTED". Hardcopy / Printout of online application received through proper channel after the last date of receiving application will also be "REJECTED". Non-submission of self attested Hardcopy of online submitted application alongwith requisite documents will be REJECTED.

GENERAL INSTRUCTION :

- (i) Interested candidates must apply only in **ONLINE** mode. Detailed instructions for filling up the online application form are available in the following link: <http://www.saha.ac.in>
- (ii) **Application fee of Rs.500/- (Rupees Five hundred only)**. The application fees should be submitted through **online remittance** only. All Women candidates and candidates belonging to PwBDs (Persons with Benchmark Disabilities) are exempt from paying application fee, as per extant government orders. SC/ST candidates are exempt from paying application fee for the posts reserved only for respective category.
- (iii) The candidates who are not exempt from paying examination fee may submit the requisite fee through **online remittance only**. Fee once paid will not be refunded under any circumstances. Fee paid by modes, **other than online remittance**, will not be accepted and the applications of such candidates will be rejected forthright.
- (iv) Self attested photocopies of documents in support of age (school passing certificate / admit card/passport), educational qualification, experience, PwBDs Certificates etc. of the candidate must be submitted along with Hard Copy / Print out of Online application.
- (v) Persons suffering from not less than 40% of the relevant disability are only eligible for the benefit of reservation. Persons with disabilities (PwBD) fulfilling the eligibility conditions as prescribed under GOI instructions are encouraged to apply. Persons with Benchmark Disabilities (PwBDs)

can also apply for the post not reserved for PwBDs but Identified for PwBDs in accordance with provision of Ministry Social & Empowerment Gazette No. 38 16/2020-DD-III. Dtd. 04.01.2021 & Para 25 or DoPT OM No. 36036/3/2004.Estt(Res) dtd. 29.12.2005.

- (vi) Applicants who are employed in Government/Quasi Government/Autonomous Institute/Public Sector Undertakings etc. should apply **through proper channel**. Forwarding letter from the employer indicating Vigilance Clearance (Hardcopy) is required.
- (vii) For candidates who are not employed at the time of application, but become employed subsequently, and called for interview, must arrange for NOC (with vigilance clearance) reach SINP before the date of interview.
- (viii) No correspondence from the candidates will be entertained regarding their selection/test/ interview/appointment. Canvassing in any form will disqualify a candidate.
- (ix) THE INSTITUTE RESERVES THE RIGHT TO FILL UP OR NOT FILL UP THE POSTS(S).
- (x) **Any subsequent amendments/modifications etc. will be notified only in the Institute website which the interested candidates should visit frequently.**
- (xi) Candidates appointed will be governed by the New Pension Scheme introduced w.e.f. 01.01.2004.
